VISION 2020: Seeing the Signs Clearly

WHEN YOU THINK OF THE NEXT 10 years, what do you picture? Here at Cancer Services, we see lots of possibilities, all centered around our agency's strategic plan and all geared toward the improvement and empowerment of cancer survivors in the 10-parish area.

Vision 2020 is our roadmap—our guide—for where we aim to take the agency over the next decade. As we think about our future, we reflect on enhancements we made this year. To name a few, we created new online networking groups for cancer survivors, incorporated Zumba Gold into our exercise program and added another video to our DVD series for Fit & Fearless. We also partnered with a local distributing group purchasing organization to lower our costs for nutritional supplement, medical goods and office supplies. Our ability to think ahead, provide innovative services for clients and collaborate with other agencies in the community make it possible for us to consider long-term goals such as the ones in Vision 2020. As we journey with cancer survivors, our roadmap will help us make the right stops along the way.

What do you see beyond the horizon? Here, we see a future of continued service excellence. A future of innovation, relevant to the needs of cancer patients. And one day, perhaps ... a future without cancer.

This year, we entertained 438 people from our Candlelighter and Kids Kare children's programs by hosting 20 activities and field trips to help get their minds off of cancer. "After my diagnosis, I got a wig, scarves and nutritional supplement to keep me going. I went through a lot of pain and discomfort, but I made it with your help! ANNUAL GIVING PROGRAM INCREASE We can't do what we do without the generosity of our

community. Since our Annual Giving Program began in 2008, we have raised nearly \$300,000 each year to help provide client programs and services. Our goal for Vision 2020 is to double this amount annually in order to make it possible to reach our other goals.

OUTREACH WITHIN REACH

Today, we have outreach locations and distribution sites throughout the greater Baton Rouge area. Vision 2020 includes a plan to let every cancer patient in the entire 10-parish service area know that we are here to help them. We want to increase our ability to serve cancer patients in outlying areas with support groups closer to home, the possibility of a mobile unit and whatever else it takes to reach those who can't reach us.



Clients can attend free exercise classes several times a week, including Fit and Fearless, yoga and the new Zumba Gold class. In 2010, we had 73 regular participants in this program. We also created the second Fit & Fearless DVD in our video series for cancer patients

EXPANSION OF OUR BUILDING

It's no secret that space is limited at Cancer Services. Vision 2020 includes plans for additional building space to allow more room for survivorship programs and offices. "When I get the invitations to attend Mom's Night Out for moms who have children with cancer, I feel just like my young daughter when she goes to Camp Care! I get so excited each time—I can't wait to attend the events!"

This year, we expanded our ability to network with clients, donors and volunteers via the Internet. Our Facebook fan page now has more than 700 followers. We are also active on Twitter and connect regularly with supporters through our monthly e-newsletter, The CS-Express. Most recently, our adult and children's program department created their own Facebook fan pages for clients to interact online. And we have added cancer survivor blogs to our website.

NO CANCER PATIENT LEFT UNSERVED

It grieves us to know that there are cancer patients in many areas who need our help but don't live in one of the 10 parishes we serve. Vision 2020 includes a plan to expand our service area and coordinate an effort to reach more outlying communities, so that those who are in need can obtain care from Cancer Services.

\$6 MILLION DOLLAR ENDOWMENT

Since its inception in 1959, Cancer Services has benefited from the generosity of individuals. Their legacies are reflected throughout our campus—in our buildings, our incredible programs and services, and, most of all, in the grateful expressions of our clients. Less visible, yet equally important, is the impact that individuals can have by remembering Cancer Services by contributing to our endowment, The Howell Legacy Fund. Our wish is to reach \$6 million by 2020.

In January of this year, we began facilitating a monthly cancer survivor support group at LCIW the Louisiana Correctional Institute for Women. This specialized group provides an outlet for comfort and information to those who are imprisoned and dealing with the effects of a cancer diagnosis. This new group shows that just as cancer can affect anyone, so too can our mission. We are truly here to improve life for those living with cancer—no matter the circumstance.

Seeing the need

Through the Eyes of a Client

l was a librarian.

I was the director of a public library system. I was diagnosed with follicular lymphoma on July 16, 2008.

l was fired from my job two weeks later. **I was devastated.**

I returned to Baton Rouge 30 hours before Hurricane Gustav hit.

Baton Rouge was devastated...

I came to Cancer Services that week. The building had no electricity. It was hot and dark, yet I was greeted warmly and began my journey with cancer here amid kindness and helpfulness.

I came here afraid. It was here that people began addressing my concerns with me. Respecting my feelings, they never tried to force me into decisions about my treatment, but instead told me of the many lymphoma survivors. I began attending the blood cancer support group and met people who had been through treatment. In the group I could voice my fears, and people who really understood listened and gave me the support and hope I needed to get through treatment.

I also came here indigent. I had no income. Cancer Services helped me with mileage reimbursement, which made it possible for me to receive the on-going chemotherapy and testing that was required. Cancer Services supplied me with nutritional supplement as well. And, they paid for the medications I needed to make years of chemotherapy tolerable. I do not believe that I could have survived this illness without their help and support.

Most recently, Cancer Services approved my request for therapy. Through their help, I was referred to a clinical social worker who had also dealt with a devastating illness. She had also lost all means of financial support: her job, her car, and family. Our sessions have given me **hope** that when I finish my treatments for cancer, I will eventually be able to have a job and a life again.

Cancer Services continues to support me through my illness and treatment. They have created a family for me—a family of staff and families of clients—who make me feel welcome and wanted. Thank you, Cancer Services.


